# How does this Privacy Policy apply?

This Privacy Policy applies to DiRoots websites, web services, desktop and mobile applications. By using our applications and services, you agree to the collection and use of information in accordance with this policy.

#### Information Collection and Use

## What Information do we collect and process?

While services and apps, we may collect and process certain personally identifiable information that can be used to contact or identify you. # How do we store your data?
